Indian naval ship in Sweden for 2-day visit

Indian Navy's frontline stealth frigate, *INS Tabar* commanded by Captain MR Harish arrived at Gothenburg, Sweden on Wednesday for a two-day visit.

India and Sweden share warm bilateral diplomatic relations that span diverse fields, including defence relations. The visit by *INS Tabar* to

Gothenburg, Sweden aims to strengthen these bonds and also explore newer avenues of bolstering the relationship in the maritime domain, the Defence PRO stated.

INS Tabar is equipped with a versatile range of weapons and sensors and is among the earliest stealth frigates of the Indian Navy. The ship is part of the Indian Navy's Western Fleet, based at Mumbai under the Western Naval Command.



Minor siblings burnt alive in Odisha blaze

KENDRAPARA: Two minor siblings were burnt alive in a house fire in Odisha's Kendrapara on Thursday, police said. The fire is suspected to have been caused by either an LPG cylinder leak or a short circuit at their home in the district's Balarampur village.

The victims were Anupama Sahani, 11, and her younger brother, Rishi, 9. The incident took place when their parents were out at a market buying rations, police added.

The flames were so intense that despite efforts of locals and fire officials, the blaze could not be extinguished in time to save the children. Their charred remains were recovered from the gutted house, police said.

Police have launched an investigation to determine the exact cause of the fire, with assistance from fire

department officials.

Meanwhile, the district administration has expressed condolences and sanctioned an ex gratia of ₹60,000 to the next of kin of the deceased.

Mother, girl among 3 dead in car crash

BILASPUR: A mother-daughter duo and one more woman were killed after their car rammed into a stationary truck in Chhattisgarh's Bilaspur district on Thursday, police said.

Two persons were injured in the accident, which occurred on Pendridih bypass road at 3.30am when the victims were returning after having dinner in a hotel, a police official said.

"Preeti Sharma, 48, her daughter Shruti, 19, and another member of the family Shreya Sharma, 24, died. Preeti's son Ankit, who was driving the car, is among the two injured. The two injured persons were hospitalised and their condition is critical," he said.

Police have registered a case and launched an investigation, he added.

Gomti Nagar case accused: I was framed

LUCKNOW: An accused in a recent molestation case, in which a woman was allegedly groped by a mob while traversing a waterlogged street in the Gomti Nagar area in UP's Lucknow, met Samajwadi Party president Akhilesh Yadav on Thursday and claimed he is being framed in the matter because of his caste.

After the meeting with the opposition leader, accused Pawan Yadav claimed he was not present at the crime scene and was taking tea when police nabbed him. He said he was nowhere to be seen in the footage of the incident and suggested he might have been framed due to his Yadav caste.

"One inevitably gets caught in the grindstone and perhaps me being a Yadav led to this," Pawan Yadav said. Talking to reporters at a party meeting on I-Day, Akhilesh Yadav, without naming the accused, said, "He had come here. He had gone to have tea and police picked him up." He wondered why, during an assembly session, two names were mentioned by CM Yogi when others could have been included.
